PRIVACY ACT 1993

1. Personal information collected from prospective members will be held by KIRRA and its sub-committees, and will be used in furthering the interest of property owners and residents of Kawau Island and generally in promoting their welfare in accordance with the aims and objects of the Association.
2. From time to time, where appropriate, personal information may be disclosed to other organisations or individuals whose aims and objects are compatible with, or directly related to the aims and objects of KIRRA, including but not necessarily restricted to Civil Defence and Kawau Island Advisory Committee. Information concerning the names, addresses and occupations of members will from time to time be made available to the Registrar of Incorporated Societies in accordance with the provisions of Sec 22(3) of the Incorporated Societies Act 1908.
3. Personal information relating to members will be held by KIRRA, Kawau Island, as she is currently responsible for membership matters. Any change to this will be notified by the Association in the Kookaburra.
4. The Association is required by the provisions of Sec 22 of the Incorporated Societies Act 1908, to keep a register of its members, showing the names, addresses and occupations of its members. The supply of that information by each individual member is therefore mandatory.
5. Each member has the right to request access to his or her own personal information, held by the Association, and may request correction of any such personal information that is incorrect.
